

- f. Brian had been blocked on my phone and as many devices as possible because he was stalking and harassing me. He was logging into my accounts, calling me incessantly and also reaching out to my mother threatening her safety/reputation and mine. He then was able to email me and wrote a threatening email stating that he had reached out to the sister of a former boyfriend of mine that passed away from an overdose earlier this year to tell her the "negative" things I'd said about her and they could speak about me for "fellowship". He reached out to her via LinkedIn. He also went through several other contacts to find the Uncle of a good friend of mine, and reached out to him to further tarnish my reputation with lies and harassment that have caused me immense emotional and physical distress. I am constantly living in a state of fear. I also believe he created a website about me and made it public asking people to reach out to an email address before becoming "professionally or personally" involved with me.
- 2. a. much in a state of power. This was far from the first time it had happened, and he promised each time that if I stayed and worked for him he would never make that mistake again. It happened over five times that I have recorded. I made it very clear, in a text stating to him that "it would never happen." He threatened to take away my job, stop paying for my health insurance, etc. and used physical intimidation to keep me stuck. He threatened that if I ever took him to court, he would "make sure I would regret it" and would "hear from a lawyer" right away. This escalated over days. I texted him "I have nothing to hide. Please stop texting me, please let me alone, I've been begging you. Please. You're scaring me." Needless to say, he did not stop with his physical advances or attempts to intimidate me and bully me.
